A WORLD OF NUCLEAR POWERS? Edited by *Alastair Buchan*. Englewood Cliffs, New Jersey: Prentice-Hall, Inc., 1966. Pp. 166. \$1.95 spectrum series paperbound; \$3.95 clothbound.

The book contains a collection of essays on the subject of the proliferation of nuclear weaponry.

CIVIL LIBERTIES AND THE CONSTITUTION. By *Paul G. Kauper*. Ann Arbor, Michigan: The University of Michigan Press, 1966. Pp. vii, 223. \$1.95 paperbound.

Based on a series of lectures given by the author, Professor of Law at the University of Michigan Law School, at a summer school for lawyers in 1961, this book is designed to acquaint the general reader with constitutional issues that lie beneath news reports of civil strife.

INSIDER TRADING AND THE STOCK MARKET. By *Henry G. Manne*. New York: The Free Press, 1966. Pp. ix, 189. \$6.95.

Professor Manne presents legal and economic analyses of insider trading, and he concludes that it possesses a measure of legitimacy and results in no significant injury to long-term market investors.

LEGAL ADVISERS AND INTERNATIONAL ORGANIZATIONS. Edited by *H. C. L. Merillat*. Dobbs Ferry, New York: Oceana Publications, Inc., 1966. Pp. xvii, 113. \$3.75.

This volume presents a report by The American Society of International Law of a conference of legal advisers to international organizations held at Bellagio, Italy, in August 1965.

THE AMERICAN JURY. By *Harry Kalven, Jr.* and *Hans Zeisel*. Boston: Little, Brown and Company, 1966. Pp. viii, 499. \$15.00.

This eagerly anticipated volume, the principal report of the study of the American jury system undertaken at the University of Chicago Law School, presents a general theory of jury decision-making based upon the most extensive collection of criminal trial data ever gathered in the United States.

THE EVOLUTION OF INTERNATIONAL ORGANIZATIONS. Edited by *Evan Luard*. New York: Frederick A. Praeger, Inc., 1966. Pp. 328. \$9.00.

The book contains a series of essays which examine the changes which have taken place in the structure of the most important international organizations of the world today and attempt to isolate and assess the factors that have influenced their evolution.

THE MARITAL DEDUCTION AND THE USE OF FORMULA PROVISIONS. By *Richard B. Covey*. Indianapolis, Indiana: The Bobbs-Merrill Company, Inc., 1966. Pp. ix, 115. \$7.50.

The author provides a comprehensive analysis of the basic and hybrid formula bequests to a surviving spouse, comparing their operation and effect and suggesting forms for each.
